

**Minutes of a Meeting of Stoke Hammond Parish Council held on
Tuesday 5th April 2022 at 7.30pm**

1. Apologies for absence

2. Co-option of Parish Councillor Vacancy

Two co-option applications were received for Cllrs consideration, with one candidate, Craig Champion, in attendance. Mr Champion addressed Cllrs in support of his application, and Cllrs proceeded to vote. Cllr Humphreys proposed Mr Champion, with Cllr Sharkey seconding. The remaining Cllrs voted unanimously in favour of co-opting Mr Champion to the Parish Council. Mr Champion signed a declaration of acceptance in the presence of the Clerk and joined the table with fellow Cllrs.

6. Update from Unitary Councillor, Phil Gomm, as follows:

- Congratulations to Claire Critchlow, for having been awarded the Proud of Bucks "Highly Commended Best Adult contribution" within the Ward for her services to the community. Being present at the meeting, Cllr Gomm presented Claire with an award for which she deservedly received a round of applause.
- If any residents in the Parish are hosting Ukrainian refugees, BC are offering a great deal of help.
- The NLS school bus issue has been resolved and the 9 children that didn't have access to the service now do.
- Would like to re-iterate that I'd like to know anything to do with County issues, so residents should feel free to reach out directly and I will look into matters quickly for you.
- Whilst Tyrells Gardens does need a re-surface and is in the capital programme, pothole repairs have been marked out and will be carried out this week. Cllr Sharkey confirmed they'd been done today.

The Chairman asked whether there were any questions for Cllr Gomm:

- A MoP mentioned there has been a number of messages on the FB group regarding the High Ash bus route that could do with some clarification. Cllr Gomm asked to be looped in on the FB post so he can take a look and respond.
- A MoP mentioned the disintegrating bridge over the brook where the sleepers are rotting badly. Cllr Gomm said there is an issue with timber right now and only two in the team doing work for the whole of the North, however, he would pick this up with the Rights of Way team. **Action Cllr Gomm**
- A MoP asked whether there was any update on previous transport conversations regarding parking on Newton Road once the potential new nursery opens. The transport team concluded there was no risk and granted on a daily basis it might not look like a problem, however, once you put 45 children and parents into the mix it's just going to make that road very narrow and dangerous. Cllr Gomm understood the point being made here but was unable to comment further.

Clerk's Update

- The two Queens Jubilee benches are due to arrive w/c 18th April so Cllrs should give consideration as to where they want them installed. *The Chairman stated that the view of the Jubilee Committee was to place one bench under the tree on the Sports Field that was planted by Prince Philip.*
- The new village pump has been delivered and will be installed in the next few weeks.
- Will get roofing quotes to Cllrs in the next week or so for repair of the BS garage 1 roof.
- McDonalds have agreed to a no branding litter bin at the top of the concrete path so I'm now trying to co-ordinate this with Marcus but currently struggling to get hold of him, which also leads me on to the installation of the bin outside the shop. I've emailed three times now and left two voicemails but he's just not getting back to me which is strange, so I do hope everything is ok.
- The three VAS application forms in regards to our new solar speed signs were submitted to Buckinghamshire Council on 17th March and I have given Swarco the heads up that once we receive approval, an order will be placed for three solar signs.
- Winslow and Villages Community Board today announced their new Co-ordinator. Her name is Sophia Comer and I've already reached out to say hi and wish her all best wishes in her new role. The funding process for 22/23 will be open for applications in the coming weeks.
- The big pothole by the zebra crossing was repaired last week and our LAT has the pavement outside 22 Fenny Road high on his radar. He also marked out areas in Tyrells Gardens yesterday.
- I put a request in for the zebra crossing to have a new lick of paint and change of lights to LED. This is now with the Street Scene team for consideration.
- As requested at last month's meeting, I commissioned an inspection survey of the trees within the village. I believe this was carried out last week and am just awaiting RTM's report.
- I submitted a road closure application on 25th March for the Sunday of the Jubilee event. All being well, the obligatory 2-week notice should go up next week.
- My year end meeting with our Internal Auditor is scheduled for 9.30am on Bank Holiday Monday, following which I will finalise the AGAR documentation for sign off at the May meeting.

8. To report on any Highways, Footpaths & Footways and Lighting matters

- A MoP mentioned that the drain on the green was missed in the recent round of clearing. The Chairman commented that sadly that was not the only drain missed. Cllr Gomm said he was disappointed they didn't all get cleared at the same time but the Team will be back out.
- The pavement near the shop, outside The Gables remains in a bad state. The Clerk confirmed she reported this on FixMyStreet on 26th Jan but it was then mentioned that the root cause is lorries parking on the pavement so Cllr Gomm said that issue would need to be resolved before BC would consider paying out to have the pavement repaired.
- Cllr Champion mentioned that when you drive in to Newton Leys where the Taylor Wimpey entrance is, by the show homes, that corner is not very wide and has quite a bend on it where busses have to go through, and people have been parking directly opposite on both sides of the cul-de-sac. Cllr Gomm confirmed that because the roads are not adopted, it is still down to the builder, but the police could do something here as it is illegal to park on a bend or within 30ft of a bend or junction.
- Outside the village shop on the grass verge, there are generally 3 vehicles parked there all the time, which not only results in a messy verge but often means the grass cannot be cut. The Chairman said the PC would try to address this matter.
- A MoP mentioned that as you are pulling out of the Green on to the main road, just on the left hand side of that exit, there is a Missing kerbstone and a raised utility cover. The Chairman suggested that a photo be taken and uploaded to FixMyStreet.
- A MoP asked what was happening with the Fenny Road layby as it is getting worse. Cllr Gomm confirmed it is in hand and that something is in the pipeline but he was unable to give a timeline.

The consultant was unwell for the first planned steering group meeting and had to cancel; a new date has been scheduled for this coming Thursday 7th April by Zoom.
